The purpose of the Private Employment Agency (Agensi Pekerjaan Swasta – APS) is to eliminate irresponsible, illegal and unlicensed agencies. Besides that, it is also to make sure there won't be any misuse of the license to cheat both illegal workers and employers during Rehiring project recently.

We Agensi Pekerjaan WSL Sdn Bhd is one of the APS with holding JTK Licence Category C. Starting from 15th June 2019, only APS with Category C license can supply and recruit foreign workers on behalf of the employers.
